



Diploma Requirements

Key Parameters

- 220 total credits to graduate -- minimum
- Subject credit requirements
- Grade 9-11 students enroll in at least 6 classes
- Grade 12 students enroll in at least 5 classes

Course Enrollment Examples	Grade 9	Grade 10	Grade 11	Grade 12	Total Credits w/ Passing Grades
Minimum Course Load	6	6	6	5	230
Typical Course Load	7	7	6	6	260
Maximum Course Load	7	7	7	7	280



Accommodations and Modifications

Accommodations

- Addresses how a student learns material
- Course standards are not altered
- Ensures access to the course curriculum in order for students to demonstrate their knowledge and skills
- Assist students in meetinging grade level standards
- Examples:
 - Preferential seating
 - Time and a half for assessments
 - Scribe for note taking
 - Permitting verbal responses to written assessments

Modifications

- Addresses what material a student learns
- Course standards and/or curriculum is altered to fit the unique needs of a student
- May impact the ability of a student to earn a high school diploma
- Potential post-secondary implications related to 4year college eligibility, and college readiness
- Examples:
 - Modified grading system (C/NC)
 - Alternative curriculum standards



Alternative Pathway to a Diploma

Ed. Code 51225.31 -- Established by Assembly Bill 181 (June 2022)

- Local educational agencies (LEAs) will exempt students with exceptional needs who meet specified eligibility requirements from established graduation requirements
- Students who meet the specified criteria are eligible to earn a high school diploma via an alternative pathway

Goal/Intent of Legislation -- Ensure all students completing high school coursework have access to post-secondary educational and career opportunities

Eligible students maintain their free and appropriate public education ("FAPE") entitlements until the age of 22



Alternative Pathway to a Diploma

Eligibility

A student's individualized education program (IEP) must have the following provisions to qualify for the alternate pathway:

- The student is required to take the California Alternate Assessments (CAA) in Grade 11
 - The IEP team determines whether a student is eligible to participate in the CAA. The student MUST have a significant cognitive impairment AND an IEP to be considered for CAA eligibility.
 - AUHSD utilizes the California Department of Education's (CDE) tool to collect relevant data, aiding the IEP team in making informed decisions regarding a determination of CAA eligibility

- The student is required to complete state standards-aligned coursework to meet the statewide coursework requirements specified in Ed. Code
- Eligibility must be determined before a student commences grade 10

Certificate of Completion

Eligibility

Students with IEPs who are unable to meet the District's graduation requirements

Course of Study

- The student satisfactorily attends high school, participates in the instruction prescribed by their IEP and meets the objectives of the transition services (Cal. Ed. Code § 5639)
- The student completes their modified course of study as outlined in their individualized education program (IEP); or
- The student meets their IEP goals determined by the IEP team

Award Requirements

A Certificate of Completion can be awarded to students with IEPs at the end of their senior year or any time before they leave AUHSD up to the age of 22

Students who do not graduate with a high school diploma continue to have a right to free and appropriate public education (FAPE) until they achieve a diploma or reach age 22



Diploma and Certificate Options
